

Jhaharia, Sardar recommended for Khel Ratna

Devendra Jhaharia on Thursday became the first paraathlete to be recommended for India's highest sporting honour - the Rajiv Gandhi Khel Ratna - along with celebrated former hockey captain Sardar Singh. Javelin thrower Jhaharia, the first Indian to win two Paralympic gold medals, was the first choice of the awards selection committee headed by Justice (Retd) C K Thakkar.

The committee has picked 31-year-old midfielder Sardar as its second nominee for the top honour and has suggested that both Jhaharia and Sardar be considered for the award jointly.

The 36-year-old Jhaharia's two gold medals came in the 2004 Athens Games and last year's Rio Paralympics and he set new world records on both the occasions. He also won a gold medal at the 2013 World Championships.

Sardar, on the other hand, has been a constant in India's fast-improving standing in international hockey.

The 31-year-old, regarded as one of the ace midfielders in the world, became the youngest player to captain the Indian hockey team when he led the side at the 2006 Sultan Azlan Shah Cup.

A recipient of the Padma Shri, the fourth highest civilian award in India, in 2015, Sardar has two Asian Games medals - gold in 2014 Incheon and bronze in 2010 Guangzhou. He also has two Commonwealth Games sil-

Federation's All-Star team twice in 2010, 2011.

ver medals and was named in the International Hockey Federation's All-Star team twice in 2010, 2011.

1520 years has paid off. It is the biggest of all sporting honours and the credit for that goes to my teammates because without them I couldn't have achieved what I have," Sardar said. Sardar's name became a topic of debate during the meeting today due to the sexual harassment allegation levelled against him by a British-born British hockey player. However, his sporting achievements were hard to ignore for the committee.

Whether both Sardar and Jhaharia get the award or either of the two is picked, would be decided by the Sports Ministry in the next few days.

Besides, the awards selection committee has recommended 17 names for the Arjuna award. The list includes

men's Test cricket team regular Cheteshwar Pujara and women's World Cup star Harmanpreet Kaur. Paralympic medalists Mariyappan Thangavelu and Varun Bhat, golfer SSP Chawrasa and hockey player S V Sunil. The 28-year-old Pujara scored the maximum runs for India in a single season last year (F46) gold medal at the Rio Olympics Bhat, on the other hand, had claimed a silver in the same event.

Golfer Chawrasa had won back-to-back Indian Open titles in 2015 and 2016.

Hockey's battle-hardened Singh keeps on fighting

From being one of India's best hockey players to facing a sexual harassment charge, Sardar Singh has experienced every emotional crest and trough in an eventful career spanning over a decade.

At the twilight of his career, the 31-year-old has been recommended for India's highest sporting honour - the Rajiv Gandhi Khel Ratna - and he is hoping that it puts and end to the bad phase that he has been going through.

Sardar was today recommended along side paraolympian Devendra Jhaharia

for the Khel Ratna by a selection committee headed by Justice (Retd) C K Thakkar.

"That is a forgettable episode of my life. I have seen many ups and downs in my life. But now I just hope it forced them to see my achievements."

"I know I could never do any bad things with anyone. I was literally shocked when I got to know about the charge but my mind was very clear. I knew that I did nothing so I couldn't afford to live in fear," Sardar said.

Sardar made his debut for India in the junior team during India's Tour to Poland in 2003-04. In 2006, he graduated

to the senior side making his debut against Pakistan.

Known for his terrific fitness levels not only in India but worldwide, Sardar was included in the 18-man FIH All Star team in 2010 and 2011.

Sardar was later the youngest player to captain the Indian team when he led the side at the 2006 Sultan Azlan Shah Cup. He received the Arjuna award in 2012 and Padma Shri award in 2015.

Sardar has already represented India in two Olympics and is eyeing a swansong when the megacrest is held in Tokyo in 2020.

However, he is pretty clear about what he wants from his

career and is not keen to prolong his career beyond a point.

Sardar made it clear that although he aspires for 2020 Tokyo Games, he will take a call on his career at the end of 2018, a switch which will end two major sporting events in the Commonwealth Games and the Asian Games.

"My target is still 2020. But I know I am the end of my career and will see what it goes after 2018. I am still one of the fittest players in the Indian team but will assess my body after 2018," Sardar said.

"I'm not someone who will hang on to a place. Whenever I'm not satisfied with my

game and fitness, I will call it a day and make way for a junior," he added.

"But I still have motivation and the Khel Ratna recommendation will only give a fillip to that."

Although it is still early days to think about his course of action post retirement, Sardar has planned his future.

"When I quit hockey I will open an academy in Haryana. I will request the Haryana government to help me in my endeavour. Whatever I have learnt in all these years, I want to impart that education to budding hockey players," said Sardar.



Five Indian boxers assured of medals

Five Indian boxers advanced to the semifinals and assured themselves of medals at the Asian Junior Championships in Puerto Princessa, Philippines.

Bhuvnesh Kattimani (52kg), Aman Sherawat (70kg), Vinit

Dahiya (75kg), Akshay Siwach (60kg) and Siddharth Malik (48kg) won their respective bouts to enter the medal rounds.

shay got the better of Thailand's Sumatras Ontong.

However, Vijaydeep (81kg) lost 1-4 to Uzbekistan's Nurislam Ibratov in his out in the quarterfinal stage.
